Slander – The Big Lie: “The 1st Zersetzen”

The formula used is – First to slander – Then to threaten – Then to cover it up by ensuring no honest investigation takes place – Then to say you are nuts when you complain about the cover-up

Basic Questions / Test

1) How to account for defamation?

- **Excellent written references, career history, qualifications before I left Grosvenor. Psychologist CB’s Report** – “Mr. Russell presents an extremely high level of verbal intellectual ability which is superior to about 99% of the population” ... “In his interaction with other people, he is likely to be quite supportive”.... “His future course should not be limited by his specialization in accounting and there is little doubt about his ability to adapt to a variety of high level business demands”
- **Career destroyed after I left** – Thousands of jobs applied for, yet never a permanent job again in Canada. Some Freelance work; gradually disappeared - despite excellent references from them.

Judge

Case Aug 2, 2006 – (Amy threatened in Calgary July 26)

Judge:

- Ignored 20 July letter from John Leech MP that Chief Superintendent Alan Cooper advised him that an investigation was now in progress into my complaint of threats.
- Ignored disappearance of my documentation file in judge’s court papers, and refused to examine letter from Guardian Editor that same papers had mysteriously disappeared before thus suggesting conspiracy.
- Failed to call witnesses.

I told the judge that he should be ashamed of himself and that his conduct was disgraceful – as the court transcript shows (page 6).

Judge Ignores

- Numerous independent witnesses to threats – Roderick’s death threats recorded and witnessed – Witnesses threatened – Shots into his apt. threat in front of another witness. Smashing into my flat has numerous witnesses.
- Cover-Up conspiracy 100% provable from 3rd party documentation alone – refusal to investigate – blears written lies – police report provably fixed (no witnesses checked – 95% of complaint not dealt with)
- See comments in “Zersetzen Report” for precedent and (*page 4*)
- See judge’s Set Up (*page 2*)

Other Slanders

- **Incompetent Employee – Came from all angles – Mr. X and intelligence.** A cataclysmic switch off (never employed in Canada again) yet done behind my back since excellent refs from their COO and CFO – a hallmark of MI6 I/OPS Dirty Tricks.
 - 1) DS / BM (PWC)
 - 2) **Switch off, like night and day** - effect continues to this day. Ex: Kevin McBurney of Caldwell Partners / Korn Ferry
- **Drug accusation – Egon Zhender** – Told police; no follow up.
- **It’s a hoax slander, etc**
- Denis Lehane for precedent – His book “Unperson A Life Destroyed”

Defamation - A Criminal Offense

- Email to Cst. Malmgren, Calgary Police May 13, 2010 --“The defamation that still continues today is as much a part of the criminal conspiracy as it is a civil matter. Not by any means a normal slandering, it has much of the appearance of a hate crime and was designed to render me impoverished and ostracized from all contacts, and professionals were hired to achieve this. It was the **first step in the no touch torture campaign ...** it was (1) **fraudulently concealed ...** (2) **involved the intelligence services,** and (3) is the **motive for the more direct criminal threats** that came later.”

Some Quotes

- **Targets usually experience character assassination which is done to destroy their personal and professional life**
- The book *Bordergate* quotes US Customs whistleblower Ms Nunn, herself a victim of Zersetzen-style techniques - “Government attempted to paint Ms. Fitzgerald and I as ... crazy nuts”
- MI5/CIA spread false rumors that investigative journalist Denis Lehane was “insane, an alcoholic and a serial rapist” ... ultimately they got him “condemned to a psychiatric prison”. Reviews of Mr. Lehane’s book “Unperson A Life Destroyed” are on the internet.
- “It's about manipulating people or groups of people by typical STASI methods (hearsay, gossip, lies, spreading rumours about someone ... the list goes on) – German journalist.
- Victor Santoro noted in his book, *Gaslighting* - “The essence of defaming your target with rumors is it that it not get back to him.”

Bottom Line

“Worldwide Controller”... “Likely the most senior Controllorship role in Canada” (Quotes describing my job at Grosvenor from adverts placed by Grosvenor’s head-hunter the **Caldwell Partners**)

Something clearly went very wrong with my career after I left Grosvenor. Explain what it was, in terms of rumours at the time (be specific) or accept my explanation??

Government Cover up Conspiracy - UK and Canada

- ✚ March 16 2005 ordered to STOP – same date as Blears 1st letter.
- ✚ Feb 7th wrote complaining about Home Office slowness – pellet + 5 other incidents followed.
- ✚ March 22 complained about Blears letters and went to Guardian. Documentation disappearance and Guardian incidents followed.

In UK - Cover Up is:

100% provable from 3rd part documentation alone.

Leech MP “Government have not been at all helpful in all the enquiries made on our behalf”.

- **Filed a 57 page report with Didsbury police + CD and Talked 20 minutes** – Bradley writes Home Secretary; 1st Cover up by Blears (with canard of not going to police) and Intimidation. --- Leech MP writes; same Canard – Leech proves had gone to police; now new lie surfaces.
- IPCC, Manchester review pass down to same police station
- 2 -3/4 video, no follow up, **police report (no witnesses checked, complaint misrepresented)**, 95% of complaint not dealt with)
- Roderick + witness complaints also covered-up after crime numbers were issued.
- **Provable cover-up with errors of commission by Hazel Blears, Judge Jones, Didsbury Police and errors of omission (ostrich disease) by so many others.**
- **What Minister Blears letters say:**
(1) **LF 16/03/05** – From Minister Blears – Russell did not meet police *HO is not investigating & police did not investigate.*
(2) **LF 12/07/05** – From Minister Blears – Russell did not meet police *HO is not investigating & police did not investigate*

*(3) LF 29/11/05 – – From Minister Blears – Russell did meet police / Police did investigate. **Now she is stating that the matter is a civil matter.** Ms. Blears is replying to written complaints outlining serious criminal offences. **Ms. Blears is a lawyer; surely lawyers know the difference between civil and criminal law.***

(4) LF 18/11/05 – From Minister Blears – Same answer as in letter 3 – and denies John Leech MP’s allegations of “cover-up” in the Home Office, but without answering any of his specific questions.

▪ **MI5 Threats to support Ms. Blears**

LF: 14/10/05, p2 – p3. Three times threatened by Home Office/MI5 for complaining about Minister Blears’s role in the cover-up. Yes while I was complaining about Ms. Blears cover-up, MI5 (Blears was MI5 / special branch Minister) were threatening us to try and stop me complaining (*see page 31*)

[1] – **Wrote Bradley re HO slowness; pellet / blue screen incidents followed.**

[2] – **STOP incident; same day as Blears signed rejection letter**

[3] – **Wrote Bradley complaining about Blears, went to Guardian, Guardian incidents followed.**

Yes - While Blears was lying in writing, MI5 were threatening us to stop me from complaining.

▪ **Crooked Judge - Jones**

“This is disgraceful. That’s an outrageous suggestion. You should be ashamed. There’s recorded evidence of death threats in police hands. You haven’t checked with the witnesses. This is a legal lynching”

Judge refused to call witnesses - couldn’t explain why documentary defence evidence disappeared from his court papers (reason he adjourned 1st hearing) - refused to review letter re investigation.

▪ **Police Report - Didsbury Police**

95% of complaint not referred to or investigated in police report - No witnesses interviewed.

In Canada Cover-up is also:

100% provable from documentation alone

- **Police not investigating**, despite formal complaints / statements by A. and RTMR/PMR – irregularity re AVR incident (2006) as per lawyer. Police can't operate without political support where CSIS involved.
- **Bureaucratic Harassment:** Involving ministries and agencies – 2 Alta Depts (*page 27*), Electricity (*page 28*), Telephone (*page 25*); Document disappearance from govn. Offices (*page 28*); Library computers.
- **Matter brought to PM Harper** (provably) through 3 different intermediaries who know him personally, and covered-up from the top. Taken to the top because of the systemic shut down of justice, the Omerta and ongoing involvement of Canadian institutions in the cover-up – CSIS involved, Establishment elites, Police can't operate without political support. See “**Chronology of Prime Minister Harper Contacted**” (*page 39*) and file back-ups for details. Experience tends to confirm GL's statement that Stephen Harper is/was a CSIS Operative.
- 3 Public Federal Safety Ministers contacted, Alta Ministers, 2 Commons Committees (JUST – SIRC) – total Omerta
- CSIS Involved – See Security apparatus (*page 41*); Telephone Tapping & Call Interception (*page 25*); Computer & Email interference (*page 23*); my Dec 2007 call to CSIS.
- **Ostriches Disease**
Canadian Gov ducking it:
Jan 21 2009 - Replying to The Hon. Peter Van Loan, Minister of Public Safety letter to P. Robertson -- “*Mr. Van Loan what it boils down to is this – There are clear federal responsibilities as well as provincial ones – but everybody is ducking it since they do not appear to understand the concept of rule of law where the criminals are high in the establishment. It is really a question of ethics and trust in government*”

- **Canadian Human Rights Commission / CSIS**
 - **Monday 11 Aug 2008** - Catherine (780-495-8680) returned our call of a month earlier (I left a HR complaint on CHRC Ottawa answering machine) and spoke to Trisha. Said she would call me back in afternoon. She did not call. I called numerous times and left messages – no response from her (**obviously CSIS had heard the 1st call to Trisha and warned Catherine off**).
 - Aug 19th – Catherine called while we were out (as usual) and did leave a message on TELUS voicemail. But the **message** (about 20 seconds long) **had been wiped** and was blank; however I was able to call her back and leave another message since call return was working. She did not return my calls. TELUS then managed to lose record of all the voice messages (to dump the evidence). In the end A. called Catherine to make the point on Sept 10th and I left my final voice message on Sept 11th. Clearly CSIS warned CHRC off.
 - Murray Blog / CHRC & CSIS: **March 4, 2010** I posted the above example of CSIS interfering with CHRC on Craig Murray’s blog. Later that afternoon my wife and I were both intimidated in Calgary. Also TPR called from Zurich March 7, saying he had reported intrusions March 4-6 to Manchester police.
 - Yet another example of
 1. **A Human Rights organization (CHRC) frightened off by an intelligence agency (CSIS).** But more than that
 2. **CSIS covering-up for CHRC by dumping evidence,** and
 3. **Intimidating us for disclosing the CSIS / CHRC relationship on a blog.**
- **Ringers – Lauder + Prosecutor, 3 Lawyers, Private Eye, Big 4 “Conflict of Interest” *** (page 31)**

Linkage to Grosvenor

Slandering / Defamation Campaign (The 1st Zersetzen)

- 1) DS/ BM (PWC)
- 2) The switch off, like night and day - effect continues to this day.
Ex: Kevin McBurney of Caldwell Partners / Korn Ferry
- 3) Precedent for professional slander – Mr. X
- 4) Precedent for professional intimidation - 1985 California incident.
- 5) Defamation / Character Assassination is 1st stage of a Zersetzen campaign (in some cases it goes no further, and it didn't in this case for years)

Linkage to threats

Comment adversely on Grosvenor and “Zersetzen” threats follow, often the next day. Below are multiple proven examples of linkage between adverse commentary made and harassment/intimidation. There are too many examples to be coincidental:

- **Dec 2003 - The clicking incident** (page 54 of GS+CI) – Linked to my **drafting a circular email that is very critical of Grosvenor**, and does not refer to anyone else (The email is Sections B & C). The clicking occurred while I was drafting the email (not before, and not after) and stopped immediately I sent it – RTMR/PMR noticed on several calls. RMR commented on. (*page 25*)
- **The Laser Incidents** – Linked to my sending another email that is critical of Grosvenor to a **Grosvenor contact (Adrian Doble)**. The email was sent on May 20th 2004; the incidents occurred on May 21st & May 22nd 2004. Several witnesses. (*page 12*)
- **Yarm / Didsbury Computer – Keystrokes routinely monitored from summer 2002 to May 2004.** Saw at start up on regular basis by bytes going out. After Doble email notices large quantity of bytes

coming in and immediately pulled plug on telephone connection (computer was still damaged – part of laser incident series). Suggests all other similar computer incidents of which there are many relate to Grosvenor (page 12 & 23)

- The **Raymond incidents** – Mentioned the Duke and his Rolls to my daughter on the telephone in relation to the laser Incident -- Within 40 minutes of this call I had received a telephone death threat, and within 24 hours my daughter was intimidated in Aberdeen. My call was made on May 28th 2004; the incidents occurred on May 28th 2004 (approx. 40 minutes after I made the call) and on May 29th 2004. (page 14)
- LF 8/3/05 – **Grosvenor CEO denies slandering**, says nobody has made any **derogatory** (i.e. critical, diminishing) comments about me since the day I left – On same date - Diary 8/3/05: Ian McGarry advises me by telephone that Home Office will reply in 2 or 3 days. HO decides on same day Grosvenor sent letter - Home Office waiting for Grosvenor to tell them what to do (i.e. linked)?
- Diary: Tuesday 18/2/03 – 3 PM met Metin Mitchell, Korn Ferry; Robin Rogers emailed 10.42 PM – RR (key Grosvenor Contact) clearly bothered about this slander link to Grosvenor. Note Korn Ferry’s key Vanc. Man was Kevin McBurney who (years earlier with Caldwell Partners – a Robin Rogers contact), when the slanders had originally spread, had headhunted for my position.
- **Diary: 9/3/08** – RMR called; **discussed Lichtenstein. Heavy clicking** on line when Lichtenstein discussed – coming from UK end. ---- truck loitering. 10/3/08 – 7.30 am. Same truck passed as I came out of building. Mention Grosvenor’s Lichtenstein Connection. Polish Lady threatens; Truck loitering; O’s bureaucratic harassment starts.
- The **rat/gag** incident (page 54) – Linked to the intimidation sequence in general (i.e. keep your mouth shut). Witnessed by my wife and myself. The “gag” suggests that it is what I am saying that someone doesn’t like – and the only thing that I have been stating that might upset anybody are facts that contradict the slanders, and the intimidation. (page 18)

- **The 17 Sep 2004 trio of lesser Incidents happened within 48 hours of The Grosvenor Trustees receiving my 57-page report** “The Grosvenor Slandering” that I sent by courier on Sept. 14th and was received in their office on Sept 15th according to the UPS tracking report. Strangely the **Grosvenor CEO** in his written response **erroneously states that my letter was dated Sept 17th when in fact it was received the 15th.** The incidents that happened on the 17th included **a no name silent / no return number telephone call**, my **letterbox being broken open**, and my **wife’s email went haywire - for four days my wife was unable to access her hotmail account on a library computer. We noticed that other people could access their hotmail accounts, and so it was not a problem with hotmail. Others witnessed the last two events. It is interesting to note that, with the exception of my family, nobody other than the Grosvenor Trustees and CFO was aware that I had prepared and sent this report (Mr. Rogers’ copy was sent the following week).**
- March / April 2005 - **The Guardian Incidents** - Linkage to both Grosvenor and Government.

Cover Up Conspiracy / Relationships

- **Grosvenor offer yet refusal to help with investigation. If innocent, an investigation would have been in their interest.**
- **Grosvenor relationships with Intelligence Agencies and Royal family – and Trustee/Duchy of Lancaster/Courts**

Specific Threats

- **Direct Threats:** shots fired, recorded death threats, vehicles smashed into property, etc
- **Indirect threats - a thousand cuts:** street theatre, continuous surveillance, following/stalking, harassment/intimidation, etc
- **Bureaucratic harassment**
- **Cover up conspiracy.**

1) Direct Threats: shots fired, recorded death threat messages, vehicles smashed into property - A few Examples

Motor Bike (London)

June 13 2001— (1) **accelerated a motorbike fast at me in London** – I jumped, it swerved and missed me by about 3 inches. This happened close to a huge police station that is by Victoria Train Station. 15 minutes later walking along Turks Row (by York House) (2) **a car stopped beside me and the driver pointed out**, in a threatening manner, **how easy it would be to kill me**. Next few days— (3) **I was noticeably under surveillance around London**

**(1) Numerica */ Laser Incident */ Duke's Car –
(2) Raymond Threatening Phone Calls* / Amy Threatened *(Manchester, Birmingham, Aberdeen)**

Late **Thursday May 20th, 2004 I sent an email** that was **critical of the Grosvenor** world organisation to a friend of Grosvenor, **Adrian Doble** at Numerica - see section D of GS for email. Following his receipt of my December 11th 2003 email (sections B & C) Mr. Doble had telephoned me, angrily, to tell me that he had friends amongst the senior people at Grosvenor; so I was using the May 20th email to get a final message back to Grosvenor. I did not send this email to anybody else. The following happened immediately.

1. On **May 21st**, 2004 an **automatic download** came that caused my computer to immediately start malfunctioning – it took me several days to recover from this. *On Computer/PMR/RTMR **
2. On Saturday **May 22nd**, 2004 **two “No number calls”** were made to my mobile around **6.25 a.m.** & woke us up). This was unusual for early Saturday morning (We have noticed that no number / no message calls have been associated with sequences of intimidation). *PMR, RTMR**
3. **At approximately 10.30 a.m.** that morning a late model **Rolls Royce** stopped outside my apartment block for several minutes. Nobody got out. I have never seen a new Rolls Royce in this vicinity before. When I went down, the Rolls moved off. It had darkened windows and was a sophisticated light blue metallic colour. When the car moved with the change of sunlight the colour seemed to darken. It was clearly a paint job with a psychedelic side to the colour. **This car could be traced**
4. **At around 12 noon a laser beam was fired into our sitting room; both my wife and I observed this.** *RTMR / PMR*

Because my flat was 3 floors up and given the topography of the land the beam, must have been fired from at least 50 to 100 yards away. The room lit up with a very bright flash accompanied by a loud noise that sounded like one of those very old fashioned cameras, though much louder. The beam had entered through the shut window at an angle and bounced off the mirror on the wall, also at an angle. RTMR observed additional phenomena which PMR did not see. Coming off the mirror there were sparkles fizzing [like a Halloween sparkler]. I also saw the sparkler affect at the base of my computer, and suspended in air just between the mirror and the window. *PMR/RTMR**

5. The following week my wife and I checked our email accounts in the Didsbury library. PMR’s email (hotmail) had been resorted – I couldn’t get into my email (btinternet) though I could access other Internet sites using my own pin number. When I used my wife’s pin number on another computer, I could get into my email account. The next day everything was back to normal *PMR/RTMR**

Nothing happened for the next few days.

1. On **Friday May 28th**, 2004 at around 5 p.m. **I made a mobile call to my daughter** during which **I referred to the laser incident**, I mentioned a description of the **Rolls Royce** and suggested that it was foolish of them to have cased the place in such an identifiable car. Though I could not see who was in the car, I did mention that the only people whom I have ever met and who are resident within half an hour or so of this area and would likely own a late model Rolls Royce are the **Duke of Westminster** and / or the Grosvenor Hotel in Chester. *RTMR/AVR/Call record**
2. This elicited an immediate response from the OCG (Organised Crime Gang) who appear to have lost their cool as they **called me 40 minutes later** on a mobile phone from a traceable number [this is the first time that such a call has been made from a traceable phone]. The gentleman said his name was **Raymond**, that he was from “**The Security Organization**” and that he was a **friend of one of my sons** [which he is not - it was an implied threat against my son] and that he was “**very worried about my security**”. He further stated that he was the person who is responsible for looking after my security (I have never heard of him). I told him that he had the wrong number. He then responded “give me your other number then” – I hung up. ***Stolen phone confirmed by police****

An hour later I called him on my landline, and he couldn't remember that we had talked, stating that he talked to many people. He did however ask me if I worked for the same “security organisation.”
*RTMR/TPR/PMR on line/Phone bill/Police confirm stolen phone**

3. On **Saturday May 29th** - Following this sequence of events a threat was made to **intimidate my daughter in Aberdeen**, where she is a university student.

The Guardian* / Car run into house* / Threatening phone calls* (Manchester, Birmingham)

On March 23 2005 I went to The Guardian in Manchester, UK in person and arranged to meet with a trainee journalist, Mark Smith, the following day (March 24 2005). I described how my family is being illegally persecuted, and left with him documentary evidence that a Cabinet Minister in Blair's government was involved. Mr. Smith advised that he would brief a more senior journalist (Helen Carter) and pass my documentation on to her.

Returning home on March 24 from The Guardian's Office my wife and I were threatened in the name of **His Royal Highness**. A week later **my eldest son** (then in Birmingham, UK) received a series of very nasty **telephone death threats (April 1-2 2005)**, which he recorded (police crime number 20/E2/3302/05); that same night my **wife** was woken by the cell ringing - with **two weird text messages**. 24 hours later a **vehicle was smashed into my house in Manchester (April 2 2005)**. Meanwhile **my documentation disappeared from The Guardian's secure office**. I subsequently met with their then Northern Correspondent, David Ward. He told me that he would recommend to his Editor that an investigative journalist be put on the case. The Editor turned him down

Nobody except my wife and I and The Guardian knew we had visited their office since we were very discrete. **What corroborates:** The **telephone threats were recorded**, the **property damage had dozens of witnesses**, and the Guardian's **Editor apologized in writing (April 19, 05) for having lost my documentation**. A transcript of the death threats is on the Internet. What the Guardian "lost" was letters that prove that then UK Cabinet Minister Hazel Blears, who had oversight for MI5, was trying to cover up my case. A year later I filed copies of this same documentation with a Court in Manchester, and it disappeared again for the second time.

The skidding Truck incident (Calgary): threatened for telling the Washington Post about my 2005 "The Guardian" incidents" ~

March 4/5th 2011 I corresponded with Jeff Stein of the **Washington Post** about my "**Guardian**" story. At 12:05 on **Sunday 6 March 2011**, I was walking down 30 Avenue near the corner with 14th Street SW. Two hoods skidded across the road deliberately and rapidly in a truck just as I walked past them. They then got out of the truck. When I questioned the larger of

the two guys (6' 4" plus) about his dangerous driving asking him if it was deliberate and aimed at me, he started swearing and got very threatening. Probably just a hired on for the job, I don't think they knew what it's about. So I told them that it's about basic justice and rule of law, about abuse of power by people close to royal circles. As the smaller guy walked over to get into his own car (a smaller 4 by 4) to drive off I asked him to tell his handlers what I had said, and he said he would.

And yet another Guardian / MI5-6 related incident in 2012:

On Aug 17 2012 I Published commentary in "Media Lens" entitled "Guardian is too close to MI5 / MI6". That same day (PM) a car nearly drove my eldest son and a friend off the road when they were driving near Zurich (RMR / JE).

Amy threatened - 8th Street Bridge (Calgary)

My brother-in-law in Calgary attempted to provide help to look into this issue. It became abundantly clear that [the help](#) (lawyers, private eyes, etc.) [was getting scared off](#). There is huge 3rd party evidence of this.

24/7/06 -- by email and phone call [I asked my daughter Amy in Calgary to write down all that was happening](#) to the help.

26/7/06 -- [Amy was accosted and physically manhandled](#) on the street in Downtown Calgary as she crossed under the 8th. Street bridge. The hood had followed her from her place of work. As he stopped her from moving and banged her on the shoulder, he said "Don't do it. Just don't do it" (i.e. don't write the report that I had asked her to write about the "help" being scared off).

The officer said he could tell that from his modus operandi that [Amy's assailant had had intelligence operational training](#) (MI5 or CSIS?).

Shots fired* (Birmingham)

Nov 2007--Shots fired into the living room of my eldest son's house in Birmingham. **Reported to police (with spent shot handed in) by my son Roderick Russell (same name as self) and German National ******
********* who were joint complainants and witnesses. Witness further intimidated in this series of threats.

Specific Threats (continued)

2) Indirect threats: The death of a thousand cuts: Street theatre, surveillance, stalking, harassment / intimidation (A few examples)

- Circa 1,000 No Name / No Return Number / No One at the other end telephone calls*
- Prior to Feb 2001 – C. 800 No One on Line Phone Calls* + Open Surveillance / Following + Intimidation (watching right up to house; in garage) + Street Theatre AND SLANDERING / DEFAMATION*

Blue Screen Incidents

On Monday February 7th 2005 I wrote to Mr. Bradley complaining about the lack of the Investigation that the Home office had promised; and followed it; here is what happened

- Wed Feb 16th Evening – Car just below my apartment window sat outside for some time. I leant out the window to look at it. The back seat was packed with electronics (like computer servers piled on each other). The driver was looking at a blank (blue) laptop screen (on seat beside him). After 15 to 20 seconds from my opening the window, he turned the screen off and drove off. It was not an electronic map. I thought I was meant to see it and feel threatened - typical gang stalking behaviour.

- Thursday **Feb 17th** Afternoon. Walking to the Withinton library – Noticed a vehicle (4 by 4) and its driver [behaving in a fashion similar to that noted in previous intimidation sequences](#). The Library being closed, I walked along the Wilmslow Rd. to the Didsbury library.
- At the junction with Lapwing Lane, [a soft pellet fired from a vehicle hit me on my left temple 2” from my eye](#) – it bruised me, and caused a break in my skin. The pellet disintegrated depositing something (possibly sticky water) on my forehead. PMR saw the blood.*
- I entered the Didsbury library only to find that I had an [email, purportedly from the US Government \(obviously not\) accusing me of viewing unauthorised web sites](#) (absolute rubbish!!). Yes we get spam, but not this one before.
- **Saturday Feb 19th** after 10 PM. [My son had just gone out](#) for the evening (my children’s safety has already been threatened). I lent out the window to smoke. [A car \(two men in it\) drove up under the window and sat there with its headlights on for a minute](#). I stared at it. It then turned its headlights off and just continued to sit in the driveway – nobody got out. I came inside and the car drove off.

RAT/GAG Incident*:

- As an example of the most recent of these “other (i.e. ongoing) incidents” – **July 23/24th, 2004**. On Friday July 23rd my wife and I left the Didsbury Library by the Barlow Moor Road exit. A car (silvery coloured Toyota Celica) drove up fast right onto the pavement in front of us and gyrated backwards and forwards (i.e. reversing and going forward) – drawing attention to itself. I noticed, as I was meant to, the last three letters of its licence plate, which were “**RAT**”.
- Approximately 5.00 PM on July 24th (the next day), my wife and I were returning from a walk when we noticed a 4 by 4 parked near our apartment on the North East corner of the junction of Spath Road and Holme Road. When we were about 20 yards off it started up and began gyrating not just backwards and forwards but backwards right across the road – drawing attention to it. The last three letters on its

licence plate were “**GAG**”. The message that I thought was being sent is that – we would be treated like a RAT (i.e. killed) if we weren’t GAG (i.e. silent) about the slandering. The RAT incident happened during the day on a Friday in central Didsbury, one minute from a police station. Like the motorbike incident, it appeared to me that the OC is above the law (??); as if it had an official sanction.

Street Theatre

1. Just following the Laser sequence of incidents, I was **walking up Barlow Moor Road** towards Didsbury Village. When I was about two hundred yards up the road, **a car accelerated very rapidly** from a standing start at great speed making a lot of noise – The car was a brownish North American car of late 1960s / early 1970s vintage.
2. A few days earlier a women had approached both myself and my wife in the library (quite separately) in a strange way, and did not approach anybody else. *
3. Earlier in 2004 I was walking past a bus stop on my way to buying the Sunday papers when I saw an **old man with a large bloody wound in his neck. A lady rushed round the corner saying “oh, oh, oh, oh, oh”**. Since the wound was completely unrealistic, I ignored them.
4. In 2003 **in Yarm a man with head injuries** repeatedly came up to my wife and myself in Yarm (not to anybody else) drawing attention to his injuries*
5. **14th street theatre incident (youth chased down hill by hoods* – so obvious) – Car surveillance – Motorbike and photo (2007)***
6. **Rufus/Fergus incident*; P. in lake of the woods – rock fired from van re early morning walk (wed Aug 8 – Aug 9 2007)***

Harassed out of Apartment

Polish lady – campaign re apartment harassment begins (see emails); landlord harassment ** (and Karen incidents – see emails) – **Electricity situation lasts till Feb. 2008** when resolved; i.e. threats to cut off for non payment, requests for invoice, no invoice arrives but more cut-off notices, etc.

(NB - Nov 2007: Shots fired at RMR and Jana in Birmingham)**

See wicked emails sent to landlord in Human Rights / Apartment folder (desktop bottom left) for details of being harassed out of apartment. Also folder ALTA GOV PROBLEMS

Can identify 2 lower level operatives. The 2 Polish women in 50's – probably trained as butterflies in East Europe, and subcontracted to MI5/CSIS

Moving Harassment et al **

(Phone harassment, Street theatre & Mafia threat, Shots fired at son**, Bureaucratic Harassment losing report for March pay-out)****

In Aug/Sep 2007 harassing out of apartment, electricity cut off threats, job-ostracizing operation in Calgary, and Metropolitan's hounding of PMR begins.

Moved March 2 2008, Notified Metropolitan about "loss" of Gov. Files, and about Apartment Harassment.

Polish woman walk/glove incident + broken glass on sidewalk + truck loitering same day and following. Ms. O "loses" March payout report. Multiple "weird" Patricia Russell telephone messages. Street theatre in Library + MAFIA threats.

Events:

Nov 2007 - shots fired at Son/Yana in Birmingham. In 2007 harassed out of apartment, electricity cut off threats, job-ostracizing problems, and metropolitan begins

Moved SAT March 1 2008 - Further emails re deb

5/3/08 – called metropolitan. Asked them to review file that they had never seen. Mentioned continued billing despite welfare.

8/3/08 – p-woman: walk/glove – pm glass on sidewalk (night)

9/3/08 – r. called; discussed Lichtenstein. Heavy clicking on line when Lichtenstein discussed – coming from UK end. ---- truck loitering.

10/3/08 – 7.30 am. Same truck passed as I came out of building.
11/3/08 – called w. nothing sent. Ms. O left 10th for holiday until 25th – no check sent for march. **Ms O. loses report at end of February for March pay-out**
15/4/08 – “Patricia Russell” weird message call 888-606-3976, ref 080423625 – Amy called # not in service; **15 of these weird calls in last month.**
27/4/08 – 9.30 am on walk – photographed as; 1.30 pm leave library car front plates “MAFIA

Published “Lies, threats, and Government Cover-up” – 2008 **

(Phone interference, Bureaucratic interference, and Prescription problem/Health harassment)

Handed in 2008 Article to Ms. O on May 2, ²⁰⁰⁸. She lost P’s letter re apartment lease affecting moneys due; **cancelled medicine without notice** which could have been life threatening. Meanwhile **several weird telephone calls**. *The purpose of this deliberate action (cancellation of medication without notice, which for her could be life threatening) was either to deny my wife necessary medication, or to harass her by having her believe that it would be denied until the last moment. How did this happen?”*

Events:

April 30 2008 - Published “Lies, Threats and Government Cover up - published **2/5/08** handed in article “Lies, threats and Cover-Up” to Ms. O
6/5/08 Ms. O – lost report / attachment at end of Feb for March payout – lost Peter’s letter re rental change.
7/5/08 – am – Sandra Fraas – will get directly to PM.
12/5/08 – 2 telephone calls, no answer, munching sound.
13/5/08 O’s supervisor TW
22/5/08 emailed Ms. O asking if she has found letter re lease, and advising that we haven’t received monthly card of record.
24/5/08 Prescription picks up problem. Who cancelled it without notice?
30/5/08 Telephone discussion Ms O with Trisha - you raised concerns re my CPP pension situation - see letter June 2 to O. In fact the letter to me was signed 18 Feb but the envelope it was sent in was postmarked May, some 2-1/2 months later
2/6/08 - Formal complaint to Deputy Minister Howe resolves it

McMaster University Confirmation**

(Immediate threats, phone interference, mugging)

Events:

27/10/08 – Trisha – flowers for murdered daughter. Same day as University confirmation.

Telephone # 403 229 0864 voice mail - * 31/10/08 Trisha Complaint**

7/11/08 – voicemail not functioning again (asked P. to cut off voicemail and bought answering machine.

12/11/08 – strange telephone call “please hold while we connect you” then nothing.

13/11/08 – 1.15 pm call rings no one on line.

17/11/08 – (Monday) Amy mentions our landline is not working. R. mentions in off since Sunday. Problem is switching, cured at 3.00 pm Tuesday 18 after p. contacted them.

20/11/08 – (Thursday) call from r. he was mugged by 10 black guys, punched and his mobile stolen. – happened earlier this week. My telephone out till Tuesday, r. mugged and phone stolen

Canadian Human Rights Commission / CSIS **

(CSIS frightens CHRC off - Mentioned on CM blog: RTMR/PMR intimidated Calgary, PMR intimidated Manchester)

March 4, 2010 I posted the example of CSIS interfering with CHRC on Craig Murray’s blog. Later that afternoon my wife and I were both intimidated in Calgary (**Returning from Marda Loop with PMR – 2 cars observing us (Jag X + BMW); strangely parked, on consecutive corners, flashing headlights (in daytime) - typical stalking behaviour**). Also TPR called from Zurich March 7, saying he had reported intrusions March 4-6 to Manchester police.

- When I reconnected to the internet, the message **“House of Tears”** came up on my screen.

June 10, 2010 12:42 AM - This message was posted on CM's blog by Larry from St. Louis at June 10, 2010 12:42 AM.

- **“For egging on Roderick Russell, if someone horribly happens to him or someone around him, you'll own part of it. And you won't care.”**

Computer & Email Interference **

West Vancouver

Yarm

- Keystrokes routinely monitored ***

Manchester:

- 17/9/2004 – PMR shut out of hotmail account for 4 days. Relates to 4 incidents re sending GS report to Grosvenor Trustees. *
- Pattern of disrupting email accounts at library, etc. (generally 1 incident in each intimidation series) *
- Spy program (spybot) installed and discovers spying software.
- Yarm / Didsbury – Keystrokes routinely monitored *** from summer 2002 to May 2004. Saw at start up on regular basis by bytes going out. After Dobble email notices large quantity of bytes coming in and immediately pulled plug on telephone connection (computer was damaged – part of numerica/laser series) – See GS Report.
- **Library in Manchester:** As for Calgary (1) to (4) below + Resorting email accounts to show intrusions / periodically shutting accounts down / threatening screen. *

Calgary:

- LF: 13/3/07 – Leech MP confirms my emails to him being hidden (Spam Filter). *
- Email 29/8/08 – Phil Chamberlain email to AVR of 29/9/08 confirms emails sent to me didn't get through. Mary Hammer quote to me - “It's strange my friend's mother's email has been out for a week. Leech MP confirms my emails to him being hidden (Spam Filter). LF: 13/3/07
- Computer reported intrusion. Diary 2/4/09 ***

- Turned Laptop Off. Box signalled that it was still transmitting – must have been downloading my database or keystrokes. Diary: 12/5/09
- **Library in Calgary:** Frequently hijacking control of the computer and (1) freezing it – often when I am criticizing CSIS / MI*s or Government (showed library assistant) (2) interfering with keystrokes so that what comes out is gibberish (3) changing items already input or messing around with spacing so that documents go haywire, etc. (4) reading passwords (5) stopping individual input and output from showing, even though I am in the email account (examples available) (6) inserting bugs like wikidotslash. Two formal written complaints (librarians shown examples) **

Sep 12 2009 - Email Obliterated. **

My email account, rtmrussell_ba_ca@yahoo.ca, was criminally hacked into, all past messages (c. 2,000) were obliterated which was their purpose in wiping the account, and a completely false message sent to those on my address list. More recently (2010 - Feb 2011) another account clyn2der@yahoo.ca has **been grossly interfered** with, almost continuously, while **using the library computer** - library personnel have **witnessed**; letter with screen examples proving interference sent to Library Board.

Nov 9, 2009 - Pat Buchanan's site **

The URL linkage <http://Zersetzen.wikispaces.com> in a comment I published on the Buchanan site had 2 commas added so that the URL link didn't work. The site was amazed.

July 15 2009 – WikiDotSlash **

<http://Zersetzen.wikispaces.com> the dot switches to a “/” (i.e. slash). On an email sent to a Parliamentary Committee the URL still appears on the email as a dot, but acts as a slash on the Internet so that the URL Link won't connect.

2 April 2009 – Mostlywater **

Computer reported intrusion. Noted that **mostlywater** URL ref changed to **mostlywoter**.

Telephone Tapping and Call Interception **

Proof my telephones are tapped, calls intercepted and interfered with, using CSIS/MI5 interception centres. Much more evidence available:

Yarm Landline

- **The clicking incident.** Continuous warning clicks on telephone line in run up to issuance of Dec 2003 circular email – RTMR/PMR noticed on several calls. RMR commented on.*
- See Note *** On Train – **3 Spies**: They had **seat reservations** next to mine on crowded trains, which **required knowing my reservation in advance**, and the **only way MI5/6 could do that is by tapping my phone** (or spying on Railway's booking system)

Manchester Mobile Line

- **Raymond telephone threats** – I made critical comment re Duke of Westminster in call to AVR; Threatened on phone minutes later – obviously my call was overheard because my phone was tapped in real time. *
- **Amy Calgary incident.**

Calgary Landline

- Diary: 19/12/07 – Peter/Trish confirm telex fax signals (i.e. that **incoming calls are being answered with fax tones**)**
- Diary: 9/3/08 – RMR called; **discussed Lichtenstein. Heavy clicking** on line when Lichtenstein discussed – coming from UK end. ---- Truck loitering. 10/3/08 – 7.30 am. Same truck passed as I came out of building. **
- Diary: 22/5/08 – Peter and self talk to TELUS Security – unhelpful but advised they don't tap without police say so. **
- Diary: 15/6/08 – RMR calls c. 12.10 pm – I heard ringing for 3 calls. RMR says **first call answered to fax tones, second to answer machine message, third connected.** **
- Diary: 11/8/08 – Catherin (??) CHRC – **CSIS tapping my phones and warned her off.** ***

- Diary: 18/8/08 – 12.30 am **R. called saying he had tried to leave many messages that didn't work – no message service or fax tone. T. calls to say my voicemail not working** properly. P to send another letter to TELUS**
- Diary: 19/8/08 – **Telephone message blanked**, but could return call, call returned to 403-234-8169, which said line not in use (odd).*
- Diary: 12/9/08 – **Roderick called about 15 times. Rang here but no one on line.** Finally got through. **
- Diary: 13/10/08 – r. called & mentioned that yesterday (Sunday) **he had tried calling 6 times.** The one did not even go to my voicemail.*
- Diary: 19/10/08 – a. called. Apparently on Friday c. 4.00 pm she called 3 times and no voicemail.
- Diary: 6/9/09 – R. called from Zurich saying an engaged tone on line 2 minutes earlier. I hadn't had a call for an hour.

Diary: Oct 31, 2008 – See Desktop Proof/AltaGov File for details of PMR complaint to TELUS re voicemail malfunctioning, and TELUS kept cutting her off.

Diary: 7 Nov 2008 – **Voicemail not functioning at all. Trisha calls TELUS 3 times for umpteenth time. TELUS cut her off twice in mid-conversation and can't explain reasoning** on 3rd call. When voicemail recovers all messages lost (note connection to CDN Human Rights). Peter writes TELUS CFO again. **

Most of the evidence on telephone tapping has not been recorded specifically in the diary. On Friday October 31st 2008 PMR called the TELUS 310 2255 number. Two separate contacts were made, each of which was cut off midstream during the conversation. On the 3rd contact they could not explain (1) why our telephone voice mail had not been working for several weeks (2) where messages we know were left on the “voice mail” had gone (i.e. CSIS information centre) (3) why our calls were cut off in midstream.

Same time frame as - *Nov 2007 Shots fired at RMR and Jana in Birmingham* - Apartment harassment begins (see emails)

Documentation Disappearance - Government offices **

Alberta Employment & Immigration.

The irregular facts:

1. Diary: **March 11 called Ms. O re nothing sent** – Ms. O had left 10th for holiday until 25th – **no check sent for March**
2. Diary: 6/5/08 **Ms. O – lost report / attachment at end of Feb for March payout – and lost peter’s letter re rental change.**
3. Diary: 24/5/08 (Saturday) **Alta Gov. cancels medicine**; coop informed, not us; 26/5/08 – **Trisha calls Ms O – no reply**; 27/5/08 – Trisha calls Ms O; 30/5/08 (Friday) – **Trisha talks to Ms. O.**

“Twice documents filed to your attention have mysteriously got lost, thus twice stopping our monthly cheque. A few months ago **our monthly report and related pay slips** were filed at your front desk. They **disappeared.** As you were on vacation the matter was resolved with the kind help of your Supervisor Tracy Watson. Recently **a communication** from my Brother in Law **re the lease situation** was sent to you. **It disappeared as well, though it was most certainly mailed by Peter.”**

Mix Up re CPP Pension -

“In fact the letter to me was signed 18 Feb (2008) but the envelope it was sent in was postmarked May, some 2-1/2 months later” - Clearly CSIS playing games.

Health / Prescription cancelled without notice

“On May 24 PMR went to pick up her monthly prescription at the Co-op. It had been cancelled by government without anybody advising her. The pharmacist was surprised and concerned. She called you a couple of times earlier in the week, finally getting through on Friday and you sorted it out for her. But who cancelled it without notice”

To Linda Miller - Deputy Minister Health & Wellness: *“One {item} of particular concern that related to your Ministry was referred to in my earlier fax under the Caption “Wife’s Health”. The purpose of this deliberate action (cancellation of medication without notice, which for her could be life threatening) was either to deny my wife necessary medication, or to harass her by having her believe that it would be denied until the last moment. How did this happen?”*

Health & Wellness (Metropolitan) - Billing Dispute

To Linda miller:

“I asked metropolitan to review the letters that had been originally sent to the Ministry. They could not find them, and I confirmed this in writing; which suggests that the correspondence had been removed from the file in your Ministry -- the government's correspondence file included (1) telephone discussions between various Ministries (welfare) (2) two letters from my wife that outlined her position, and duly (3) completed forms requesting Premium Waiver.”

Alberta Wellness / Metropolitan continuous harassment of PMR throughout 2008 until stopped in Nov following my communications with deputy minister that explain Zersetzen

Alberta Employment & Immigration. Contact always Ms. O ~

- Last minute no notice cancellation of necessary prescription (May 24 2008) subsidization; bothered pharmacist who had never experienced this before. Two calls to Ms. O went unresponded to, finally sorted matter out on last day – serious life threatening bureaucratic harassment
- Documentation losses (2 and 3) twice Monthly reports and related pay slips filed in front desk of Ms. O’s office got lost – thus stopping monthly check. Resolved by supervisor Tracy Watson who was amazed this had happened, and twice
- PDR sends lease to Ms. O (4) her office loses it but does not query until I bring issue up.
- 4 items of difficult to explain “errors” from a Ministry that knows the situation and should be on guard.
- CPP letter re Ms. O.

Canadian Human Rights Commission **

- Monday 11 Aug 2008 - Catherine (780-495-8680) returned our call of a month earlier (I left a HR complaint on CHRC Ottawa answering machine) and spoke to Trisha. Said she would call me back in afternoon. She did not call. I called numerous times and left messages – no response from her (**obviously CSIS had heard the 1st call to Trisha and warned Catherine off**).
- Tuesday Aug 19th – Catherine called while we were out (as usual) and did leave a message on TELUS voicemail. But the **message** (about 20 seconds long) **had been wiped** and was blank; however I was able to call her back and leave another message since call return was working. She did not return my calls. TELUS then managed to lose record of all the voice messages (to dump the evidence). In the end A. called Catherine to make the point on Sept 10th and I left my final voice message on Sept 11th. Clearly CSIS warned CHRC off.

Library *

- Diary: 26/8/09 – Calhoun Library Complaint. Some details in diary. 6 attempts to get into email on apple blocked. Allowed to view then it jammed. Happened before. Trisha arrived – I complained loudly – suddenly it worked. Trisha and I tried to look at Mi5 / Stasi on Google and computer jammed. 2.45 PM complained to librarian and everything started working. Same problems numerous other occasions. See letter Sep 12 2009.
- 9 Jan 2011 again written complaint to Library. Repeatedly won't let me access email details on library computer (librarian saw; web pages on file) yet tested that AVR can access these details on her own computer.

- Amy threatened (Summer 2006) when requested to draft Ringer Report

Specific Threats – Home Office / Hazel Blears **

Linkage to earlier complaints to Government:

One three occasions when I tried to press The Home Office for an investigation, I was met by a barrage of further criminal intimidation. Here are the facts.

- On Feb 7th I wrote to former MP & Home Office Minister Keith Bradley complaining about the slowness of the Home Office who had been telling us for two months that they were investigating my issues. I stated that it was clear that the Home Office were deliberately sitting on it to cover it up. I suspect Mr. Bradley passed my letter on to The Home Office. Between Feb 16th and Feb 19th five incidents of intimidation took place, including my being hit on the head by a pellet fired from a gun. My wife saw the bruising and blood on my forehead. (See my email Feb 25th to Keith Bradley for the details of the other incidents). I thought the gangs didn't like my complaint that the investigation appeared to be stopped; hence the intimidation – yet they could not have known about my comment from me!!
- On March 16th the crime gangs ordered me to STOP. I could not see the significance of this order at that time. Several days later, I received through Mr. Bradley a letter from Hazel Blears that put a stop to the Home Office's "pretended investigation" – Ms. Blears stated reason for stopping the "pretended investigation" has now been proven to be untrue. The date on her letter was March 16th and now I knew what the STOP signal I had received on that same day was about. They couldn't even wait until the ink was dry on Ms. Blears signature before the gangs had rushed out and ordered me to stop from making further complaints.
- On March 22nd I wrote to Mr. Bradley complaining about Ms. Blears' letter pointing out the significant errors of fact that are within it, and stating that it was just a cover up – I also stated in this letter "I can only assume ... that they don't want to find the truth. Presumably the Organised Crime Gangs can be relied on to keep me silent" and I'm sure he passed it on to The Home Office. Two days later I went to The Guardian and saw Mr. Ward, the Northern Correspondent. The crime gangs reacted and the intimidation included: (1) The death threats

against my eldest son which were recorded and reported to the Kings Norton Police, (2) the Diana death threat which Patricia and I witnessed, and (3) having a vehicle (in the middle of the night) smash into and destroy the brick porch that was directly under my bedroom. Four people witnessed this. Coincidentally the documentation (just photocopies) that I deposited with The Guardian all disappeared from their offices, and there is a letter from their Editor apologising for this and stating that he cannot explain how it happened.

- Aug 8 2007 – **Rufus/Fergus incident**; P. in lake of the woods – rock fired from van re early morning walk (wed Aug 8) – Aug 9 2007
- **14th street theatre incident** (youth chased down hill by hoods – so obvious) – Car surveillance – Motorbike and photo
- **Polish lady** – campaign re apartment harassment begins (see emails); landlord harassment ** (and Karen incidents – see emails) – **Electricity situation lasts till Feb. 2008** when resolved; i.e. threats to cut off for non payment, requests for invoice, no invoice arrives but more cut-off notices, etc.
- (**NB - Nov. Shots fired at RMR and Jana in Birmingham**)

- 2007 to Feb 2008 – **Harassed out of Apartment.**
- March/April - **Weird name “Patricia Russell” messages** – Amy called two of them “not in service”
- Diary: **March 8 Polish woman. Walk/glove – glass on sidewalk night.** Mention Grosvenor's Lichtenstein Connection. Polish Lady threatens; Truck loitering; Ms. O's bureaucratic harassment starts
- Diary: March 9 2008 – R. called, discussed Lichtenstein connection: heavy clicking when Lichtenstein discussed in Call. Later a truck loitered around me.

Diary: March 10 7am – same truck loitering as I came out of building.

Intimidation sequence in both UK & Canada

- Diary: March 11 called Ms. O re nothing sent – Ms. O had left 10th for holiday until 25th – no check sent for March
- Diary: 15/4/08 – “Patricia Russell” weird message call 888-606-3976, ref 080423625 – Amy called # not in service; 15 of these weird calls in last month.
- Sunday 27 April 2008 – Photographed as intimidation at 9.30AM – Noticed surveillance in Library – on way back at 1.30 “Mafia” threat
- Diary: 6/5/08 Ms. O – lost report / attachment at end of Feb for March payout – and lost Peter’s letter re rental change.
- May 7th 2008 got letter and attachment to Sandra Fraas for direct delivery to the PM
- Diary: 12/5/08 - 13/5/08 O’s supervisor TW
- Diary: 22/5/08 – peter and self-talk to TELUS Security – unhelpful but advised they don’t tap without police say so.
- Diary: 24/5/08 (Saturday) Alta Gov. cancels medicine; coop informed, not us; 26/5/08 – Trisha calls Ms. O – no reply; 27/5/08 – Trisha calls Ms. O; 30/5/08 (Friday) – Trisha talks to Ms. O.
- Diary: 15 June 2008 – RMR phoned (1) calls responding with fax tones, or sent straight to voice mail. I was in.
- Diary: 10 July 2008 – Sandra leaves voice message – Ottawa just slow (May 7th 2008 got letter and attachment to her for direct delivery to the PM).
- Diary: Catherine CDN Human Rights – 780.495.8680. Called me 11/8/2008. Did not respond to my return call messages. A month later (after repeated calls from me) left me a voice message which was blanked out.
- Diary: 18/8/08 – 12.30 am R. called saying he had tried to leave many messages that didn’t work – no message service or fax tone. T. calls to say my voicemail not working properly. P to send another letter to TELUS.
- Diary: 12/9/08 – Roderick called about 15 times. Rang here but no one on line. Finally got through. Previously it always connects on the 3rd call.

- Diary: Sept 29 2008 – **Phil Chamberlain emails** Amy confirming that emails sent to me were intercepted and didn't get through.
- Diary: 13/10/08 – R. mentioned that yesterday (Sunday) he had called 6 times and could not get through (voicemail not working)
- Diary: 16/10/08 – circa 1pm noticeably being watched by 2 people in library, including Chinese guy who kept trying to strike up conversation outside my apartment. (Emailed peter at time). 17/10/08 A. told us she called 3 times and no voicemail. 18/10/08 yellow motorbike.
- Diary: Oct 27 2008 receive **confirmation (from McMaster** Univ as to speech) dated Oct 26. On Oct 27 day **lady buys flowers from Trisha to put on grave of murdered daughter;** lady seems remarkably cheery.
- **Diary: Oct 31, 2008 – See Desktop Proof/AltaGov File for details of PMR complaint to TELUS re voicemail malfunctioning, and TELUS kept cutting her off.**
- **Diary: 7 Nov 2008 – Voicemail not functioning at all. Trisha calls TELUS 3 times for umpteenth time. TELUS cut her off twice in mid-conversation and can't explain reasoning on 3rd call. When voicemail recovers all messages lost (note connection to CDN Human Rights). Peter writes TELUS CFO again.**
- **R. mugged in Birmingham**, punched and phone stolen – My phone in Calgary not functioning for several days until Tuesday Nov 17, 2008 – so R. can't get through to tell us

2009

- **Diary: 2 April 2009 – Computer reported intrusion. Noted that mostlywater web ref changed to mostlywoter.**
- Diary: 4 April 2009 – T. called. He could hear me, but too much interference for me to hear him.
- Diary: 12/5/09 – Turned Laptop Off. Box signalled that it was transmitting. I was not sending anything – must have been downloading my database or keystrokes.
- **Diary: 21/7/09 – Proof of . (dot) / (slash) re wikispaces in diary.**
- **Diary: 26/8/09 – Calhoun Library Complaint.** Some details in diary. 6 attempts to get into email on apple blocked. Allowed to view them it jammed.

Happened before. Trisha arrived – I complained loudly – suddenly it worked. Trisha and I tried to look at mi5 / stasi on Google and computer jammed.2.45 complained to librarian and everything started working.

- Diary: 6/9/09 – R. called from Zurich saying an engaged tone on line 2 minutes earlier. I hadn't had a call for an hour.
- 12 May 2009 – Turned laptop off. Box signalled that it was transmitting. I was not sending anything. Must have been downloading my database or keystrokes. Trisha witnessed. Quite A LOT OF THIS OVER WEEK.
- **Diary: 12/9/09 – (Saturday) 3.30 am this morning all rtmrussell ba ca yahoo obliterated and a false message sent out** - D. Stephenson called to inform me, as did Amy and r. – 13/9/09: Officer Wallace – 09338345

2110

- Feb, 2010 - Anonymous people falsely link my name (and my full contact details - telephone number and address) all over the Internet with SUICIDE; another SMEAR, but one that is a criminal offense. I traced the blog/message originator back to source and involved the police in May.
- Diary: 4/3/10 PM – returning from Mar Da Lupe Safeway with PMR – 2 cars observing us (jag X + BMW) - stalking. **Relates to today's Murray blog posting of mine re CHRC** – under caption “rare TV appearance”
- 7/3/10 (Sunday) – Talked to T. in Zurich. He mentioned intrusions in Manchester in the last few days before he moved and that he had **reported them to police**. [Ref – Diary 4/3/10 – 7/3/10]; Witnesses RTMR – PMR - TPR
- **“For egging on Roderick Russell, if someone horribly happens to him or someone around him, you'll own part of it. And you won't care.”** Posted by: Larry from St. Louis on CM Blog at June 10, 2010 12:42 AM
- **Computer Intimidation**: My comment #96 under CM Blog article “while I was away” on 19 Nov 2010 re **involvement of Vancouver Headhunters, Caldwell Partners & Korn Ferry**. From 21/11/10 to 24/11 10 the phrase “**House of Tears**” (changing on 24th to “House of Pain”) flashed across my computer screen on start-up.

2011

- March 6 2011 - **Skidding Truck incident** (Calgary) - March 4/5th 2011 I corresponded with Jeff Stein of the **Washington Post** about my "**Guardian**" story.
- March 31 to April 3 – Multiple **computer intrusions** while drafting this **Report**; details in diary - usual spacing games messing documents up, or font size changed and rotated 90° or phrases deleted as if there was another keyboard operating in the background; finally **Word hacked into and made inoperative so that it will neither open a file or save an already opened file.**
- May 30 - Sent complaint **letter to Director, CSIS**. Between June 5th & 10th : **stalked** by p. cars on at least 12 occasions on June 5th, weird calls re computer security, 2 days later T's **computer destroyed** by downloads.
- Oct 4th meeting - **SIRC** rejects my complaint without any review. Oct 6: Mac **computer destroyed** - Oct 8: New computer malfunctions - Oct 12: Wife's prescription cancelled, later reinstated, due to "glitch" - Oct 25 - 27: **Serious smearing** ensues (see diary & separate report)
- Aug 30th: - Email re False phone messages "telephone number discontinued"
- Nov 2/3 2011 - On CM Blog **commented critically on CSIS & SIRC**, the serious smearing and on Grosvenor's "intelligence" connections. Nov 3rd: cell phone stops operating. New cell phone bought Nov 8th and within hours all incoming calls on new phone are being illegally routed to somebody else's voicemail - sales clerks said that they "**have never seen this happen before**".

2012

- March 26th - My email "clyn2der" hacked into, contact list obliterated, but my emails (unlike previous hacking - 12/9/09) untouched.
- March 30th - **Crowfoot stalking** - Details on separate schedule.
- May 10-14th: **Mercedes** Incidents: I was driving the Volvo. **5 Incidents** (3 occasions) with late model black Mercedes CLS gyrating around **drawing attention to itself and deliberately driving dangerously**. May 14: The transmission incident???? - Details of these incidents on separate schedule.
- AM Aug 17th: Published article in Media Lens "Guardian is too close to MI5 / MI6". Same day PM: **Car nearly run off road in Zurich** (RMR / JE). Returned home Aug 30th - Sep 1st: **P. car incident** 8th St. / 17th Ave. SW Calgary (see diary - RR / PMR)

- Dec 8/9th Comments Prism / CM re **Flanagan / Harper** et al on CM & Prism Blogs -- Dec 13th Odd call re an unknown “Louise Thomas from Gatineau Quebec”. Dec 14th (2) **overt surveillance** incident in Walmart nr. IKEA. Following which (3) **obstruction in car causing loud shrieking noise when driven** (RR / PMR). Other recent dangerous car incidents include: Zurich incidents, Mercedes incidents, and in past year AVR experiences 2 blowouts & nail in tyre 3 times.

Grosvenor's connections with MI5/6 and CSIS

Facts:

- Re “Mr. X Incident” – Blom advises that ##### has MI6 contacts
- Re “Southern California Incidents” – ***** has own contacts (he says responding to #####’s question, he is sure that they can keep it quiet but that he doesn’t “like using them”) – ##### said if ***** is unsure, he has London contacts who are certain – Didn’t mention who, but probably intelligence services or near intelligence.
- Duke boasts to prostitutes (it’s in the press) about his intelligence connections – MI6 & CIA
- Duke’s royal connections (according to press – “so close they almost regard him as being a member of the family”) certainly bring MI5 / 6 into picture. Monarchy brings with it intelligence connections in UK. Also a history of use of intimidation.
- Duke’s Military connections - Deputy Chief of UK Defence staff
- Look at Security Apparatus for practical proof of intelligence involvement; starting with the 1986 slandering (precedent Mr. X). Link between Grosvenor and Zersetzen – and clear link between Zersetzen and MI5/6 & CSIS.

Royal Involvement?

- Grosvenor’s owner “Duke of Westminster” has been reported to be Prince Charles’s best friend and “so close to the royals that they almost regard him as one of the family”. His sister in law has admitted a 25-year erotic relationship with Prince Philip. Jimmy James (head of Grosvenor when I was there) went on to run The Duchy of Cornwall for Prince Charles. Do the Royals use the MI*s to settle private business (DS’s brother, Valet Smith’s threats, Burrell, etc)??

- The **Diana threat** (after Guardian visit). Would expect that UK police would go bananas about misuse of royal identity. Yet, saw police viewing car and doing nothing, even though it was illegally parked, which suggests to me they thought it might be a genuine threat from interests close to royals (as did I).
- On way to **EIM Meeting** – Clearly intelligence involved. 2 on the train (different trips) kept **introducing Royal subjects** (what did I think of them, and P. Charles, etc.) that I think they were trying to suggest Royal involvement to scare me off. I think that I was meant to realize what these people were.
- Didsbury Library – Former **Military Intelligence Major**. Over 9 months began to get friendly and drop hints since he realised that we are innocent. Sent me a note through PMR @ Xmas 2005. He was clearly getting disgusted with what was going on. Said what was needed “is another Cromwell”. Again the suggesting of a royal link, not prompted by me.
- Calgary – At Highwood: questioned about what I thought of royals not prompted by me. **Barry Styles** tells me (after he made significant attempts to help) that my enemies were too powerful and I would never get the story out. Ask him why?? Library contact begins to ask same question about Royals a year later.
- MI5/6 & CSIS persecuting a decent family whom they know to be completely innocent of wrongdoing ... police/government systems stymied!!
- Huge scale cover-up!! **Including 2 Prime Ministers** covering this horrible issue up??

There is evidence that suggests to me that close **Royal associates may be involved**; Evidence of a royal link not conclusive but, in the absence of an honest investigation, there is enough evidence for a reasonable person to have reasonable suspicion.

Ministers in two governments are covering it up; they must know whom they are protecting from justice.

Chronology of Prime Minister Harper Contacted

- Jan 7, 2008 – My 1st letter to PM Harper @ PMO and Constituency. Sent hard copy and by fax. Diary: 7/1/0/08 - **Julie** from PMs Office called confirming receipt of fax.
- Jan 30, 2008 – PDR’s supporting fax to Harper
- Jan 25, 2008 – RTMR’s follow up email / letter to PM Harper.
- Feb 11, 2008 – RTMR’s follow up email to PM Harper
- Feb 27, 2008 – Email correspondence with PM Harper’s constituency agent Sandra Fraas, complaining about wrongdoing by an MP and cover-up.
- Feb 28, 2008 – **Richardson MP**’s assistant (Robyn) emails me **advising that I will receive a response from Harper** or his office (I never did, and am still waiting).
- April 29, 2008 – **PDR’s reminder fax to Harper as he hasn’t received a reply (and never did) *******
- April 30, 2008 – **Richardson MP** (through assistant Robyn) **confirms by email that Day/Harper are now involved and will respond directly to me (they never did)*******
- May 6, 2008 – My 2nd Letter to Harper. **Hand delivered to Prime Minister’s constituency office and discussed their with office manager Sandra Fraas who agreed to see that my letter gets to Prime Minister Harper personally (i.e. not just to the PMO).**

- May 30, 2008 – Peter’s letter to Richardson pointing out errors in Richardson’s and Police Chief’s alleged statements (Cover-up) re crime and letter from Leech MP – errors (?) that are well known to Richardson and never been answered. Responding to Richardson’s 30/4/08 letter to PDR.
- July 10, 2008 – Diary: **Sandra** [Fraas from PM’s constituency Office] left telephone message, in response to my follow up query re our May 6 meeting - **Ottawa just slow**.
- **Sept 11, 2008 – RTMR email (with support) to Sandra Fraas (Harper’s constituency agent) complaining that the evidence of inaction now shows that Harper is involved in the cover-up.**
- Feb 23, 2009 – My follow-up email to **Van Loan** (cc PM Harper, Alberta Attorney General) re my original detailed response to his 9 Feb 2009 letter to PMR. Note that I received no reply.

1. **Telephone tapping, and call interference** - MI5 (CSIS) interception centers in Manchester Yarm, Vancouver and Calgary (*page 25*)
2. **The Smear campaigns**
3. **Cover-up by Minister Hazel Blears** – Minister responsible for MI5, Special Branch (*page 31*)
4. **Threats to STOP me complaining** to Hazel Blears on 3 occasions
5. Intimidation is too prolonged, sophisticated and costly for a crime gang acting alone.
6. Amy's assailant - "has had intelligence operational training" (Calgary Police).
7. Death threat caller Raymond refers to the **security organization** (or service) – a known pseudonym for MI5.
8. Highly sophisticated **computer spying and intimidation**.
9. Private eye confirms that **MI5** has had a **file on me** for years
10. **Documentation** proving cover-up **mysteriously disappears** from two secure offices – The **Guardian, Judge's** papers. Documentation disappearance is a **hallmark of MI5**.
11. **Precedent** - Reported in UK / USA / Canadian press that (1) MI5 have a history of using Stasi developed Zersetzen tactics – MI6 have a history of character assassination. (2) CSIS uses D& D, Globe, Llewellyn, (3) Duke of Westminster has boasted about his close connections to the MI*s and CIA AND (4) **In 1985 Grosvenor's professional slander campaign re "Mr. X", and intimidation re "Southern California Sex Incident."**
12. **Bureaucratic Harassment** – (*page 27*)
13. **All police Investigations stopped**. A Judge provably corrupted, and a Cabinet Minister.
14. **Interference with email and mail** (*pages 23*)

Spelling / Naming, SMEARS and Quotes

Zersetzen is spelt numerous different ways in English and by me (Zersetzen, zerzetsen, zerzetzen) – It should probably be spelt: **Zersetzung or Zersetzen**. In Canada CSIS calls it “**D&D**” (Disrupt and Discredit) or **Vigorous Harassment** and in the USA it’s sometimes called New **COINTELPRO** (Counter Intelligence Project) and various other names.

SMEARS

It is almost standard practice for victims of Zersetzen to be smeared with accusations of paranoia as part of the actions taken against them by the security services. **All I can say is read the Research Paper**. You will note that there are independent eyewitnesses to some of the threats, recordings of telephone death threats in police hands, and considerable documentary proof of the cover-up.

Have a look at the other examples of Zersetzen on pages 17 to 20 of my report. To check out references to the Stasi’s original directives, Google in the word "Zersetzung"

SMEARS are untruthful rumours spread to serve a purpose in Zersetzen: (1) to provide an excuse for not investigating (smear might be - he is deranged, etc.) (2) To isolate him from the community (smear might be - he is a pedophile, or he committed a fraud, etc.).

SOME QUOTES FROM EXPERTS

- Boston Center for Refugee Health and Human Rights – “*Direct threats to him/her [the victim] or to a relative are by far the most common form of torture.*”
- Stasi Chief Markus Wolf announced that the “**psychological effects of the Stasi's harassment campaigns, 'were probably more damaging, ultimately, than any physical torture would have been.'**”
- The Manson family during their "creepy crawler" burglaries of the late 1960s, would enter homes and steal nothing, but would rearrange furniture to upset and confuse residents

- “I was subjected to harassment, burglaries... surveillance, bugging, telephone tapping ... my family suffered considerably ... my brother was killed in an accident never satisfactorily explained.” Former multinational company CEO, Gerald R. James
- MI5/CIA spread false rumors that investigative journalist Denis Lehane was “insane, an alcoholic and a serial rapist” ... ultimately they got him “condemned to a psychiatric prison”. Reviews of Mr. Lehane’s book “Unperson A Life Destroyed” are on the internet.
- Former CIA psychologist James Keehner: "It was planned destructiveness. First, you'd check to see if you could destroy a man's marriage. Then you might start a rumor campaign against him. Harass him constantly."

All normal support structures and avenues of grievance have been removed. “Power creates an atmosphere in which individuals practically feed off what they think power wants” - Assange.

Destroying a person's finances to promote homelessness is common. In the book *Bordergate* - Nunn mentioned "Both of us were forced to move back home with our parents or be forced into homelessness since we could not obtain employment to support ourselves."

The very word "secrecy" is repugnant in a free and open society; and we are as a people inherently and historically opposed to secret societies, to secret oaths and to secret proceedings - JFK
